A RESOLUTION AUTHORIZING THE ACCEPTANCE OF A DONATION OF AN ADA COMPLIANT ELKAY WATER REFILLING STATION WITH INSTALLATION TO THE COUNTY OF HAWAI‘I DEPARTMENT OF PARKS AND RECREATION.

WHEREAS, Keiki of Da Aina Foundation (K.O.A. Foundation) is donating an ADA compliant Elkay Water Refilling Station with installation to the County of Hawai‘i Department of Parks and Recreation; and

WHEREAS, this donation, valued at approximately \$2,000, is a state-of-the-art water fountain equipped with a water bottle refill capacity to be installed at the Kekuaokalani Gymnasium (Old Airport Gym) in Kailua-Kona; and

WHEREAS, Article XIII, Section 13-12 of the Hawai‘i County Charter, provides that the council, on behalf of the county, may accept gifts of donations of money, securities, or other personal property or of real estate or any interest in real estate; and

WHEREAS, the Department of Parks and Recreation recommends the acceptance of this donation; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I, , in accordance with Article XIII, Section 13-12 of the Hawai‘i County Charter, the County of Hawai‘i, accepts this donation.
